ETCETERA® Enterprise Process Management (EPM) software is flexible enough to provide insurance companies with hundreds of solutions across the enterprise. Companies can rapidly design, develop and deploy applications. In most cases the design is done by non-technical employees.

Current forms can be replaced using EPM, which is comprised of application design, online data capture, integration with host applications, automated routing and collaboration with signature capabilities, report generation and legal/audit storage and access.

The Application User Interface (AUI) can be designed for either online or offline use by employees, agents, brokers, third parties or policyholders.

Some process areas with multiple forms which provide optimization opportunities utilizing EPM include:

- Insurance applications – online and offline
- Field inspections and reports
- Medical reviews
- Workers Compensation payroll submissions
- Loss reviews
- Policy changes
- Policyholder services
- Premium invoice issuance and payments
